Step 3: Made a decision to turn our will and our lives over to the care of God, as we understand him.

Step three came pretty easy to me. Here is how it happened.

In 2017, I was found guilty of OWI 4<sup>th</sup> offense. I have never seen a Big Book, 12 and 12 book, or read anything out of the Bible. At 50 years old, I had no God or Higher Power in my life at all. I was a full-fledged alcoholic. And that is where it all started. I admitted to the Judge that I was an alcoholic and to please put me in a prison where I can learn about this disease. I lived in Wausaukee, WI out of town where you can hear a dog bark from a mile away. Now, I live in a 5x7 room with a very loud cellmate, and I can hear 380 other people screaming, arguing, and fighting. I was in hell. I was looking for a way to end it. When transferred to prison, you are only allowed to bring three things—glasses, a Big Book, and a Bible.

After three and a half days of no sleep, I was done. I wanted out any way possible. I sat up, looked around, and seen my property—two books and one pair of glasses. I put on the glasses, opened the Bible, somewhere in the middle, and started to read. After half of a paragraph of reading it was silent. I looked around. People were still screaming, arguing, and fighting. But I heard nothing. Right there and then I knew there was a God and He was with me. I was restored to sanity. I was out of hell and I found serenity. And I wanted more of it. So right then and there, I made a decision to turn my will and my life over to the care of God. Still reading the Big Book and the Bible. Over 5 ½ years sober.

In step three it talks about needing a key to open the door for a Higher Power. My key is in those two books.
