Experience, strength, and hope on **Step 11**: Sought through prayer and meditation to improve our conscious contact with God *as we understood Him*, praying only for the knowledge of His will for us and the power to carry that out.

When I first came to AA, I could totally relate to everything I heard but the "God" talk. I had long term resentment towards the religion of my upbringing and even told my sponsor I wasn't going to do the God stuff. She encouraged me to have a small mustard seed of faith that there is something out there that is more powerful than myself. That suggestion worked and I was able to find a connection with a power greater than myself. I finally accepted and acknowledged I did not control or have power over anything but myself.

I started to pray and although it was pretty selfish in the beginning, it helped me to thank my higher power when I made it through challenging situations. Through working the steps, especially step 3 and step 7, I improved my contact with my higher power, God as I understand it. I also found some prayers that used to have a religious connotation to me but have since transformed into meaningful spiritual statements. I finally understood that the higher power is not a religious God but rather a spiritual one and that helped me quite a bit. Step 11 is an action step, one that we aim to practice daily for the best results. The prayer part had become a bit more normal for me but my sponsor pointed out that these prayers ought not be pleas for control. We just need to ask for guidance to practice God's will for us. I heard once that prayer is when we talk to God and meditation is when we listen to God. This has really helped me improve my communication with my higher power.

Meditation was not completely new to me however I had always used guided meditation and was never able to sit still with myself in my mind until I practiced silent meditation with my sponsor in her living room for 10 minutes. I did get off track of staying in the present but each

time I did, I returned back to focusing on the sensations of breathing. At one point, her significant other came in the room and I felt some resentment pop up towards him as he interrupted our session. Very quickly after I had that thought, I returned to focusing on my breathing and had a thought that there is no way he could have known what we were doing and to not interrupt us. That was not my brain, it was my higher power speaking to me. I heard you, God! Finally! I quieted my brain down enough to hear something other than myself in my mind.

That experience inspired me to begin practicing meditation daily. There is a step 11 meditation for upon awakening and when we retire at night on a meditation app I use and I aim to listen to those each morning and evening. I usually find that when my day or mood is off, it's because I was slacking on my step 11 when I woke up that morning. My experience has been I get out of it what I put into it so I try to give my best effort each day. I am never alone when I practice step 11 and it allows me to show up as the best version of myself so I can be of service to others.

2023 has seen growth in interest in our service structure. We started the year with a handful of attendees at our meetings. We now have a dozen or more people regularly attending and participating. Many committees are still a "committee of one", but the energy is strong, and things are happening. For instance, P.I. is regularly contacting churches and schools and Literature is assisting with racks and pamphlets.

District 09 disbanded its Lending Library a few years ago due to lack of interest. A Literature committee has replaced it, and literature racks, pamphlets, and Service Manuals are provided to the district this way.
