My sponsor(s) insisted that service is not an option but is an obligation. Whether that obligation is to the group or to ourselves is something only we can answer. I'll just assume that you were grateful that AA was there when you needed it!

I am a big fan of the "We" form of our Responsibility Statement: WE are responsible when anyone, anywhere, reaches out for help. WE want the hand of AA always to be there. And for that, WE are responsible.

Experience, strength, and hope on **Step 12**: Having had a spiritual awakening as the result of these steps, we tried to carry this message to alcoholics, and to practice these principles in all our affairs.

My name is Debbie and I'm an alcoholic. My sobriety date is December 26, 2001. Here are some thoughts on Step 12. Having had a spiritual awakening as a result of these steps...what was my spiritual awakening? It was many small ones. As they came about, I knew there was no such thing as coincidences. I have had many small spiritual awakenings with the same feeling of immense inner peace and calmness that I believe comes from my Higher Power who I call God. I have found out that each step brings me closer to having a relationship with God. With the help of God and Alcoholics Anonymous I don't have to drink, I have a purpose, and I can help other alcoholics.

How do I try to carry the message of Alcoholics Anonymous? First, it's a we program. I pass on what I have learned from my AA sponsor and AA members. At meetings I rarely pass, I share my experience. I hang around after the meeting to talk to newcomers and other members. I put my phone number on women's lists. I am willing to sponsor women the same way I have been sponsored by reading the Big Book and working the steps. I also encourage them to sponsor and to be of service in and outside of AA. Outside of AA I carry the message by being a good person and sharing my experience, strength, and hope when called upon. I have shared my experience at a jail, treatment center, tech school classroom and a club for AA meetings. I share openly to anyone who wants to know how I stay sober.

Practicing these principles in all of our affairs means living the AA program wherever we are... home, work, church, meetings, social events, etc. My sponsor has enlightened me on how much the word usefulness is used in the Big Book. This word has helped me. How can I be useful? Wipe down tables at an AA meeting, home dinner table, work lunch table, social event banquet table. Say hi to the newcomer, your family member, a coworker, someone at a social event. Helping other alcoholics helps me to stay sober, stay accountable, and helps me live the program. I have set God and working the steps aside at times and the result was always the same. I became restless, irritable, and discontent. I have a choice. Stay in the problem and relapse or live in the solution and recover. Today I choose to stay in the solution of Alcoholics Anonymous.

Experience, strength, and hope on <u>Tradition 12:</u> Anonymity is the spiritual foundation of our traditions, ever reminding us to place principles before personalities.

Our principle of humility is the most obvious one that is expressed in this tradition. The *Twelve Steps & Twelve Traditions* states ". . . anonymity is real humility at work. . . we try to give up our natural desires for personal distinction as A. A. members both among fellow alcoholics and before the general public. . . each of us takes part in the weaving of a protective

mantle which covers our whole Society. . ." (pg. 187). When I was newly sober in AA, I was on a pink cloud like many that came before me. I was excited for the solution AA had for me. My life was slowly becoming more manageable, but I had a lot of work ahead of me, specifically working the steps. I certainly felt a desire to tell others, like coworkers and friends of friends, about my membership in AA. Looking back, I am thankful I listened to the other AAs reminding me to keep my mouth closed. I am told that I have alcoholism and not alcoholwasm. I am forever an alcoholic and that means I have shortcomings. If I were to disclose my membership in AA that could give a bad name to AA as my disease is dependent upon a spiritual reprieve. Before working the steps and creating a solid recovery program, I was still running around in self. By putting my personal desire aside to break my anonymity, even today, I have a better opportunity of attracting a newcomer to this program through practicing humility, honesty, integrity, and love, all while protecting AA.

In relation to my fellow alcoholics, I hear the anonymity closing at the end of a meeting and am reminded not to disclose who I saw or what I heard. By keeping who and what I hear to myself, I protect that person in the meeting. I protect their sobriety and mine as I depend on them to keep showing up. Trust is paramount in keeping the fellowship healthy and growing. There is no discord in my AA way of life when I preserve my anonymity and anonymity of my fellows. We all get along just fine.



DISTRICT 09 GSR MEETING NOVEMBER 5, 2023 SURING, WI

Paul Y. opened the meeting at 2:05 pm. with a moment of silence followed by the Serenity Prayer. The Traditions were read and introductions made. A sign-in sheet was passed; there were 13 members in attendance, representing Gillett, Porterfield, Suring, Oconto, Coleman, Shawano, Marinette, and Lakewood in WI.

Another member said they were called by someone from the group and that is why they are here in AA today. Jolene said there is always a great parking lot meeting after the meeting. Norm F. said the Monday night group in Gillett is doing good and the treats are always awesome. Paul Y. said the Suring group on Thursday has 3-4 core people that attend. Paul said they are going back to a Big Book study format. Paul said

they had changed their format and their attendance went down.
