#### DISTRICT 09 GSR MEETING JUNE 2, 2024 MENOMINEE, MI

Mary C. opened the meeting at 2:01 pm. with a moment of silence followed by the Serenity Prayer. Introductions were not made. A sign-in sheet was passed; there were 10 members in attendance, representing Peshtigo, Porterfield, Oconto, Shawano, Marinette, Coleman, and Lakewood in WI and Menominee, MI. A member stated that Introductions were not made, however, the DCM said she would do Introductions later in the meeting.

<u>Secretary Report</u>: The minutes from the last District 09 Meeting from May in Suring were approved and accepted. The secretary requested that the GSR sharing be kept separate from the Officer and Committee Reports as it is difficult to take the minutes when we are all over the place during the meeting. The DCM said the meeting minutes are too long and just need to be a generalization of what is talked about.

They will be in plexiglass displays. Carol said she has not heard from or followed up with Bay City Radio regarding the PSA broadcasts for AA. Carol reported there was a newcomer at the meeting she attended last night and therefore, stated the newcomers are out there.

#### An-uh-nim-uh-tee

As a newcomer, the principle of anonymity was introduced to me quickly by the groups. I heard traditions 11 & 12 read at the beginning of meetings. People chanted "who you see here, what you hear here, when you leave here let it stay here" to close out the meeting. I saw this phrase on displays set up around the tables we sat at. Other AAs showed me how they practice this principle in their lives too. When speaking with another alcoholic before or after a meeting we talked about our own lives instead of other AA members. Members would share with me how they like their anonymity to be protected and what it would mean for them if it was broken. It was explained to me by long-timers that what is shared in a non-general way, like through sponsorship, is not meant to be shared with others inside or outside of the rooms. Also, I was told by long-timers that we do not share personal information about the people we know in AA to anyone. These suggestions were evident in the meetings and fellowship I attended in early recovery.

Since I first learned about anonymity, I have been mindful of my own and the anonymity of others. Practicing anonymity of myself and others at the public level is more straightforward compared to at the level within our Society. For example, at the public level, it is simple for me to not share photos, whether in press, radio, or film, of myself and other drunks participating in fellowship. Within our Society, I believe, there is a gray area for



me because I do not always want to keep my recovery a secret. If I do, this may inhibit me from carrying out our primary purpose. For example, in service work I may share my last name with other drunks so I can communicate with them more efficiently, but I am mindful to not share the privilege of knowing other AAs last name with anyone else.

Despite priding myself on practicing this spiritual principle, there are times we fall short. I am careful not to break other members' anonymity publicly. But I have accidentally broken my own publicly. There have been times AAs wanted to share with me about another alcoholic I did not know personally, and I asked them not to. God will decide who I am to know in AAin God's time. Also, I can recall a few times I have broken AA members' anonymity who spoke at a speaker meeting by sharing with another drunk, who was not at that speaker meeting, who I heard speak. In similar ways, I have found other AAs have broken my anonymity.

As I continue to stay in AA, get to know more people in the fellowship, and get to be involved in service work, I am faced with more opportunities to adhere to this spiritual principle. I regret the times I have been presented with an opportunity to remind others about anonymity and took no action. Furthermore, I become fearful of our Society's future when I hear someone use an alcoholic's full name in a group or when I see pictures of us on public social media. I am finding anonymity is beginning to be taken lightly with AAs and they are more often choosing to break their own. I cannot help but wonder, is this a new AA? Am I the bleeding deacon? Should I jump on this bandwagon? I certainly do not want to be left behind. So, I do what AA teaches me-talk with another alcoholic, pray, and find a solution in the literature.

This is what I have found. When speaking with another alcoholic, I was encouraged to be an example for our fellowship. I shared my fear of possible backlash from other drunks if I were to speak up about the principle being

broken. I was told that speaking up about anonymity would most likely humble the group and be met with acceptance since I am honoring the traditions. When I pray and listen to God, I am reminded the easy way is not always the right way. Keeping AA united may involve tough work. In our literature, our co-founder wrote multiple letters to the Grapevine on this spiritual principle. (Literature I have used is in The Language of the Heart Bill W.'s Grapevine Writings) What I have gathered is this: We are asked to give up something for the general welfare of AA in each tradition. Anonymity is a personal sacrifice of my ambitions and desires for the safety and survival of the AA society. These ambitions are usually ones of personal power, prestige, public honors, and money. It is each AAs responsibility to draw the line on how far to break their anonymity without injuring our Society. In the past, my desire for prestige has gotten in the way of practicing this principle where instead I should have practiced self-effacement. For me, to protect AA means to show the newcomer I can be closed mouthed in that they do not fear to return to the rooms. It is not enough for us to say we are anonymous we must show it. Again, early in my recovery I saw this principle practiced. I did not fear showing up somewhere outside of AA for a non-member to recognize me as a recovering alcoholic. Today, I do have some fear of this. This fear is that I may give AA a bad name for my lack of emotional sobriety at times. But I also have hope that we are a fellowship that truly does want the best for AA and its members by following the traditions the best we can.

I will leave you with two things. One, on page 216 Bill W. writes, "So we are certain that if such forces ever rule our Fellowship, we will perish too, just as other societies have perished throughout human history. Let us not suppose for a moment that we recovered alcoholics are so much better or stronger than other folks; or that because in twenty years nothing has ever happened to AA, nothing ever can." (Copyright 1988 AA Grapevine, Inc. Reprinted with permission). Two, the *Traditions Checklist from the AA Grapevine*. This is used by individuals and groups. # Tradition Eleven: Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio, and films.

- 1. Do I sometimes promote AA so fanatically that I make it seem unattractive?
- 2. Am I always careful to keep the confidences reposed in me as an AA member?
- 3. Am I careful about throwing AA names around-even within the Fellowship?
- 4. Am I ashamed of being a recovered, or recovering, alcoholic?
- 5. What would AA be like if we were not guided by the ideas in Tradition Eleven? Where would I be?
- 6. Is my AA sobriety attractive enough that a sick drunk would want such a quality for himself?

Tradition Twelve: Anonymity is the spiritual foundation of all our Traditions, ever reminding us to place principles before personalities.

- 1. Why is it a good idea for me to place the common welfare of all AA members before individual welfare? What would happen to *me* if AA as a whole disappeared?
- 2. When I do not trust AA's current servants, who do I wish had the authority to straighten them out?
- 3. In my opinions of and remarks about other AAs, am I implying membership requirements other than a desire to stay sober?
- 4. Do I ever try to get a certain AA group to conform to my standards, not its own?
- 5. Have I a personal responsibility in helping an AA group fulfill its primary purpose? What is *my* part?
- 6. Does my personal behavior reflect the Sixth Tradition-or belie it?
- 7. Do I do all I can do to support AA financially? When is the last time I anonymously gave away a Grapevine subscription?
- 8. Do I complain about certain AAs' behavior—especially if they are paid to work for AA? Who made *me* so smart?
- 9. Do I fulfill all AA responsibilities in such a way as to please privately even my own conscience? Really?
- 10. Do my utterances always reflect the Tenth Tradition, or do I give AA critics real ammunition?
- 11. Should I keep my AA membership a secret, or reveal it in private conversation when that may help another alcoholic (and therefore me)? Is my brand of AA so attractive that other drunks want it?
- 12. What is the real importance of me among more than a million AAs?






